### **1. Opening Business**

- a. **Welcome** - Ms. Nickell welcomed everyone to the SBDM meeting.
- b. **Agenda Approval** - The motion was made to approve the agenda as presented. With there being no disagreement from any council member, the motion passed by consensus and the agenda was approved.
- c. **January Meeting Minutes Review** - The motion was made by Chris Appelman and seconded by Patty Rouse to approve the minutes of January 19, 2021 Regular SBDM Meeting. With there being no disagreement from any council member, the motion passed by consensus and the minutes were approved.
- d. **Good News-** EHMS Beta Club qualified in 19 areas in their online State competitions. This includes 32 students and they are qualified for the Nationals competition, The Academic Team placed 2nd in the region competition and many are headed to state including our Quick Recall Team, Seventh grade Boys Basketball team have made it to the semi finals and will play Thursday, February 25th. STLP Teams will join in our next meeting so they can present some of their projects.

### **2. Planning:**

- a. **State Assessment** -All that we know at this time we will be testing online and it will be a shortened version. Ms. Nickell will let us know more on this when it's available. We will start offering next week for students that are failing or below grade level to stay after school next week to try to get their grades up and homework complete. The Instruction Committee will meet to decide how long we will offer this to our students. Summer school will also be an option for students that still need help.

- b. 2021/22 School Schedule Discussion-Ms. Nickell sent a survey to the teachers about returning to the 7 period school day or remaining at the 5 period school day that we have done this school year. The teachers seem to like the 5 period day and we may want to continue this for the 21/22 school year and having a 30 minute homeroom class. This will help with the students that do not get Related Arts classes due to the 5 period days.

- a. Winter MAP data update- Ms. Nickell shared and discussed a copy of the Winter Map Data

**4. New Business:**

- a) Approval of the 21/22 Staffing Allocations- We fell below the 750 student allocation at this point so the board has cut us 3 teacher positions and 1 half time Assistant Principal position for next school year. We need a total of eight students to be able to get the full time Asst. Principal position back. Ms. Nickell turned in her data of numbers to Mr. Sutton so that they can review this decision again. Ms. Nickell didn't ask for approval on allocations at this time and will present again at the next meeting.
- b) ESS Revised Budget Approval- Six teachers and two instructional assistants are going to work after school with our students that are failing or need help. They will be paid \$25 an hour to do this. Chris Appelman made the motion to approve the budget and Amanda Todd seconded the motion.
